### **Andrew Harper Signature Group Travel**

These terms apply exclusively to Andrew Harper Signature Tours ("Signature Tours"), which are small-group travel experiences organized by Andrew Harper.

### **Acceptance of Terms**

By submitting a deposit, the participant acknowledges that they have read and understand the inclusions, exclusions, registration requirements, payment and cancellation policies, and all terms and conditions set forth herein, and agrees to be bound by them. Submission of initial deposit authorizes Andrew Harper to charge the participant's payment method for the deposit and all subsequent tour charges on their respective due dates, and constitutes acceptance of all terms and conditions. The itinerary is subject to change.

### **Pricing & Minimum Participation**

Tour pricing is based on a minimum of 14 participants. If fewer than the minimum number of travelers participate, or if there is a significant change in exchange rates, tariffs or fuel prices, a price supplement may apply and/or the itinerary may be adjusted. Please note: For this trip to proceed, a certain minimum number of people must reserve a place. We will provide confirmation once this number has been reached so you may proceed with booking airfare and other forms of transportation. If you choose to book airfare in advance of final confirmation, please book refundable fares to protect yourself against additional charges should cancellation occur.

### **Payments & Registration**

A non-refundable deposit of 50% of the tour cost per person is required at the time of booking. The remainder of the tour cost is due on July 1, 2026 and is non-refundable.

If a reservation is made on or after July 1, 2026, full payment is required at the time of booking. Payments may be made by Visa, MasterCard, American Express, personal check or wire transfer/ACH.

Failure to remit payment by the applicable deadline may result in cancellation of the reservation and forfeiture of all payments made.

### **Cancellation Policy**

Cancellations must be made in writing and received by Andrew Harper. All deposits and payments are non-refundable. No refunds will be issued for cancellations, unused services or unused portions of the tour, or early departure from the tour.

## **Inclusions**

Accommodations based on double occupancy; arrival and departure airport transfers; ground transportation, internal airfare, sightseeing, and activities as indicated; all breakfasts plus at least one lunch or dinner each day; local wine and beer with included meals; hotel taxes; entrance fees to included sites; baggage handling; gratuities for local guides, drivers, and porters; professional tour escort throughout; tour development, planning, itinerary preparation, and reservation management by Andrew Harper. Rooms can vary slightly and will be allocated according to registration date.

## **Exclusions**

International airfare; costs of passports and visas; personal expenses such as laundry, beverages, liquor/mixed drinks, meals not listed; room service, excess baggage fees, sightseeing not listed; communication charges, and personal insurance coverage. Due to the exclusivity of group contracts, member benefits are not applicable on signature group tours.

## **Airfare**

International airfare is not included. Andrew Harper can assist with flight arrangements upon request, but is not responsible for airline schedule changes, delays, or cancellations.

## **Eligibility & Fitness to Travel**

All travelers should be in good health and able to walk during touring. Signature Tours requires travelers to walk on uneven and possibly slippery surfaces and to navigate stairs. Venues may not have elevators. Some areas prohibit coaches, making walking mandatory. By submitting a deposit, the traveler certifies that he/she does not have any physical or other condition or disability that would create a hazard for him/her or others (considering one overnight in tented camp without electricity). It is essential that persons with any medical problems or related dietary restrictions inform Andrew Harper at the time of booking. All travelers are expected to be ready to experience cultural differences with grace.

## **Smoking**

Smoking is not permitted during situations that involve fellow travelers. This applies when travelers are in restaurants, sightseeing vehicles, trains, boats and other water transport, air transport, and when participating in group activities.

## **Travel Documents & Health Requirements**

All travel documents (airline tickets, passport, visa, destination-specific vaccination records, and inoculation verification) are the traveler's responsibility. It is also the responsibility of the traveler to obtain any necessary public health documents for all applicable destinations and to comply

with all customs requirements. Adherence to country specific passport validity dates and blank page requirements is the responsibility of the traveler. Without the required documents, travelers may be denied entry into a particular destination. Andrew Harper is not liable for such denial.

### **Baggage**

Baggage handling is at the traveler's risk throughout the tour. Baggage restrictions may apply. Andrew Harper is not responsible for loss, damage, or excess baggage fees imposed by carriers or suppliers.

### **Hotel Arrival & Upgrades**

Standard hotel check-in times apply. Early check-in is not guaranteed unless a pre-night is purchased. Room upgrades may be available on a first-come, first-served basis for a supplemental fee and are subject to availability at the time of request. Please contact Andrew Harper if interested in purchasing a pre-night or upgrades, if available.

### **Travel Insurance**

Travel insurance is strongly recommended for all travelers. Andrew Harper recommends the purchase of comprehensive travel insurance at the time of initial deposit. Travelers who do not purchase travel insurance at the time of booking may not be able to add coverage at a later date, and coverage for pre-existing conditions typically requires purchase at the time of initial deposit. Andrew Harper shall not be responsible or liable for any losses, damages, expenses, or claims that would have been covered by travel insurance had the participant elected to purchase it. Insurance policies are available at an additional cost.

### **Host Substitution**

If Andrew Harper has represented that a specific individual shall act as a host or guide for a Signature Tour and that individual becomes unavailable, Andrew Harper shall use best efforts to replace the host or guide with an individual of comparable expertise and qualifications. Such substitution shall not entitle participants to any refund or price reduction.

### **Responsibility & Limitation of Liability**

Andrew Harper and its operating partners purchase transportation, hotel accommodations, restaurant services, and other services from various independent suppliers that are not subject to its control. Andrew Harper and its operating partners cannot, therefore, be liable for any personal injury, loss, or damage to person or property that may occur due to: (1) a wrongful, negligent, or arbitrary act by others not under direct control of Andrew Harper and its operating partners, (2) defects in, or failures of, any aircraft, vessel, automotive vehicle, or other means of transportation not under its control, or (3) acts of God. Andrew Harper and its operating partners

also reserve the right to withdraw a tour or any part of it, to make such alterations in the itinerary as it deems necessary or desirable, to refuse to accept or retain as a member of any tour or part thereof any person at any time, and to pass on to tour members any expenditures or losses caused by airline schedule changes, delays, or events beyond its control. Andrew Harper and its operating partners are not responsible for any expenses incurred by trip members in preparing for the trip, including non-refundable or penalty-carrying airline tickets, special clothing, visa or passport fees, or other trip-related expenses. IN NO EVENT SHALL ANDREW HARPER OR ITS OPERATING PARTNERS BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, INCLUDING BUT NOT LIMITED TO LOSS OF PROFITS, LOSS OF BUSINESS OPPORTUNITIES, EMOTIONAL DISTRESS, OR LOSS OF ENJOYMENT, ARISING OUT OF OR RELATED TO ANY SIGNATURE TOUR, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE OR WHETHER ANDREW HARPER WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. ANDREW HARPER'S TOTAL AGGREGATE LIABILITY TO ANY PARTICIPANT SHALL NOT EXCEED THE TOTAL TOUR PRICE PAID BY SUCH PARTICIPANT.

### **Assumption of Risk**

Participant acknowledges that travel involves inherent risks, including but not limited to risks of illness, injury, or death, which may be caused by forces of nature, illness, or by negligent, willful, or criminal conduct of third parties. Participant voluntarily assumes all such risks and releases Andrew Harper and its affiliates, officers, directors, employees, and agents from any and all claims arising from participation in Signature Tours, except for gross negligence or willful misconduct by Andrew Harper.

### **Force Majeure**

Andrew Harper shall not be liable for any failure to perform, delay, cancellation, or modification of a Signature Tour due to circumstances beyond its reasonable control, including but not limited to acts of God, government actions, war or threat of war, terrorism, civil unrest, strikes, natural disasters, pandemics, epidemics, severe weather, or other force majeure events. In such events, Andrew Harper will use reasonable efforts to provide alternative arrangements or refunds at its discretion, but shall have no further liability to participants.

### **Photography & Media Rights**

Participants grant Andrew Harper and its affiliates the unrestricted, perpetual, worldwide right to photograph, film, and record their participation in Signature Tours and to use, reproduce, and publish such images, video, and recordings for promotional, marketing, editorial, and commercial purposes without compensation. This consent extends to any minors or other persons in the care of the participant. Participants who prefer not to be photographed must notify Andrew Harper in writing at the time of booking.

## **Miscellaneous**

This Agreement and any disputes arising out of or related to these Terms and Conditions or any Signature Tour shall be governed by and construed in accordance with the laws of the State of New York, without regard to its conflict of laws principles. Any dispute, controversy, or claim arising out of or relating to these Terms and Conditions, any Signature Tour, or the breach, termination, or invalidity hereof, shall be settled by binding arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules. The arbitration shall take place in New York, NY, and shall be conducted by a single arbitrator selected in accordance with the AAA rules. The arbitrator's decision shall be final and binding upon all parties and may be entered as a judgment in any court of competent jurisdiction. EACH PARTY HEREBY WAIVES ITS RIGHT TO A JURY TRIAL AND TO PARTICIPATE IN ANY CLASS ACTION OR REPRESENTATIVE PROCEEDING. PARTICIPANTS AGREE TO BRING CLAIMS INDIVIDUALLY AND NOT AS PART OF ANY CLASS, CONSOLIDATED, OR REPRESENTATIVE ACTION. Each party shall bear its own attorneys' fees and costs incurred in any arbitration proceeding; provided, however, that if Andrew Harper is the prevailing party, the participant shall reimburse Andrew Harper for its reasonable attorneys' fees and costs. ANY CLAIM ARISING OUT OF OR RELATED TO THESE TERMS AND CONDITIONS OR ANY SIGNATURE TOUR MUST BE BROUGHT WITHIN ONE (1) YEAR FROM THE DATE THE SIGNATURE TOUR CONCLUDED OR THE CLAIM IS FOREVER BARRED. The parties acknowledge that this arbitration provision is made pursuant to a transaction involving interstate commerce and shall be governed by the Federal Arbitration Act.

If any provision of these terms and conditions is held to be invalid, illegal, or unenforceable by a court of competent jurisdiction, such provision shall be modified to the minimum extent necessary to make it valid and enforceable while preserving the original intent and commercial purpose of Andrew Harper. If such modification is not possible, the invalid provision shall be severed from these terms and conditions. In either case, the validity, legality, and enforceability of the remaining provisions shall not be affected or impaired in any way, and these terms and conditions shall be construed and enforced as if such invalid, illegal, or unenforceable provision had never been contained herein. Andrew Harper shall have the right to replace any severed provision with a valid and enforceable provision that achieves the same or substantially similar commercial result.
